1. This constitutes an order for wedding photographs and prints. It is understood that, upon complete payment, any and all proofs, sample prints, CDs/DVDs and negatives will become the property of the bride and groom named above.
2. The client accepts that although the photographer Robert Crum takes the utmost care with exposure, processing and delivery of photographs, events outside the control of the photographer may cause him to fail to comply with the terms of this contract. In such a case, the photographer's liability is limited to the refund of the deposit.
3. Robert Crum will photograph for the number of hours stipulated in the package, and will deliver the corresponding number of products (images, CDs/DVDs and/or prints). Additional services must be negotiated separately. The bride and groom will be responsible for any further prints or enlargements.
4. Upon signature, photographer Robert Crum reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, all deposits are non-refundable, even if date is changed or wedding canceled for any reason.
5. The stipulated deposit is due at signing of this contract, with other portion to be paid by the date of the wedding.
6. Photographer Robert Crum may use any of the photographs he takes of the bride and groom for promotional purposes.
7. The client gives Robert Crum permission to post any and all photographs from the engagement and wedding on an Internet Web Web site, for viewing and purchase by wedding guests. The client also gives permission to Robert Crum to sell to guests and family the photographs taken at the engagement session and the wedding.  
In addition, the client accepts that Robert Crum will notify wedding guests of the availability of the photographs on the site by email.
8. The client accepts that while all work will be performed in a professional manner, the execution of the assignment is solely at the discretion of the photographer. Due to logistic, technical and circumstantial realities, not all picture requests may be granted.
9. No part of any order will be delivered until the balance is paid in full, by wedding date. All checks payable to Robert Crum Photography.

## Wedding Album Options

I work with [Laguna Albums](#) to create flush-mounted wedding albums that are hand-crafted with high quality materials to exacting standards. I personally design the layout for each album, and go to printing with it only after you have OK'ed the final proof.

Package 4 includes a 20-page (40 sides), 10x10" flush mounted album. I like this type of album because the pages -- which lie flat when open -- allow wonderful opportunities for creative layouts. Turning a page, for instance, to a panoramic image spreading across the entire width of the album, will always bring a thrill, no matter how many times the two of you share it with friends.

Other options are available, either to be purchased ala carte or by adding the extra amount to the base fee. Parents may order exact duplicates of the Bride and Groom's wedding album at half price. Smaller (5x5") parent albums are also available.
